General

1. There will be no dancing on Public Holidays or during school holidays, except by special arrangement.
2. Dancers who do not attend classes regularly, will not be allowed to do their exam or assessments.
3. No choreography taught at the studio may be performed or taught at any other venue/school/studio without permission granted.
4. No liability will be accepted, either by WX Hip Hop Studio or any of its Trainers/Choreographers, for any injury/accident sustained during class/off campus/activities/outings/competitions or shows due to negligence on the dancer's part.

5. ***A month's written or telephonic notice must be given if intending to discontinue tuition. Students will still be charged normal fees for the notice month regardless of attendance during that month. Should one month's notice NOT be given, fees will be charged until notice is given.***
6. If fees cannot be paid on time, management must be informed telephonically so an alternative arrangement can be made.
7. **FEES ARE NOT REFUNDABLE WHEN ABSENT FROM CLASS.**
8. Fees are payable by the 3rd.
9. **IMPORTANT: Fees are payable for a 12-month period with all school and public holidays worked in. ALL monthly fees for December must be paid by the 3rd of December. Failure to comply with this will result in the Dancer being de-registered.**
10. **Registration Fees: ALL new dancers pay an initial Registration Fee of R400.00.**
11. **Yearly Registration: ALL dancers pay an R300.00 yearly registration (payable with your December Fees.)**
12. The dance area is to be kept tidy at all times and do not leave any items of clothing in the studio as its personnel will not be held responsible for lost items.
13. Dancers must wear clothing that is appropriate to Hip Hop and Street Dance. (Please ask if there are any questions to this regard.)
14. **FEMALE DANCERS: NO REVEALING CLOTHING WILL BE ALLOWED**
15. DANCERS MUST WEAR SHOES DURING THEIR CLASS TIME.
16. Always bring water and a sweat towel.
17. Dancers are advised to switch off cell phones during dancing. It may however be used during breaks.
18. No parents allowed to sit in during classes, there will be watching days during the year.
19. **IMPORTANT: Dancers disrespecting the Instructor or swearing in class will result in immediate member cancellation. Note: We practice a zero tolerance when it comes to these matters. WX Hip Hop Management have the right to cancel any registration in the case of children/parents disrespecting WX Hip Hop Terms & Conditions.**
